

British Gymnastics Mascot Competition terms and conditions

It's important that you know all of the rules for the competition before you take part, so if you're under 18, please ask an adult (this could be your parent, guardian, coach or teacher) before they submit your competition entry, and ask them about anything you don't understand.

Introduction

- These terms and conditions apply to the British Gymnastics mascot competition housed at www.british-gymnastics.org and promoted on, but not limited to, the British Gymnastics social media channels and email newsletters ("the Competition").
- The instructions provided on the website or anywhere else in British Gymnastics channels, form part of the terms & conditions of the Competition. In the event of a conflict, these terms & conditions take precedence.
- The promoter of the Competition is British Gymnastics. British Gymnastics' company number is 01630001, and its registered office is at Lilleshall National Sports Centre, Newport, Shropshire, TF10 9AT ("we"/"us"/"our").
- By submitting an entry into the Competition, you are agreeing to be bound by these terms and conditions.

The Competition

- Entries must be submitted by an adult over the age of 18, before 15th January 2020.
- The winner will be selected and notified by email in the week commencing 20th January 2020.
- 3. Entrants must have the permission of their parent or guardian to enter if they are under 18. In such case, the entry shall be submitted by the parent or guardian on their behalf.
- 4. Entries will not be accepted from the following:
 - a) Our employees (or the immediate families of such employees);
 - Agents, third parties, gymnastics delivery partners or organised groups/ clubs: or
 - c) Any entries automatically generated by computer.
- 5. Entry is free-of-charge and no purchase is necessary.
- No incomplete, late or illegible entries or those not in accordance with the entry instructions will be accepted. No responsibility can be taken by us for entries lost, damaged or delayed either by post, computer transmission error or any other reason.
- 7. We reserve the right to verify the eligibility of entrants. We may require such information as we consider reasonably necessary for the purpose of verifying the eligibility of an entry and the prize may be withheld until and unless we are satisfied with the verification.
- 8. Only one design per entrant will be permitted.
- 9. Designs will be considered by a judging panel.
- 10. Our decision in all matters relating to the Competition shall be final and binding and no correspondence shall be entered into.
- 11. In the event of fraud, abuse, and/or an error affecting the proper operation of the Competition, including the allocation of more prizes than are available, we reserve the right to: (a) end or suspend the Competition; (b) amend these terms & conditions; (c) declare void the notification of winner(s); and/or (d) to allocate available prizes by conducting a simple draw from all wrongly allocated winners.
- 12. We reserve the right to suspend, cancel or amend the Competition and/or review and revise these terms and conditions at any time without giving prior notice if circumstances make this unavoidable. We will endeavour to avoid any disappointment or any disadvantage to those who have already entered.
- 13. If any provision of these terms and conditions is held invalid by any law, rule, order or regulation of any government, or by the final determination of any court of a competent jurisdiction, such invalidity shall not affect the enforceability of any other provisions not held to be invalid.
- 14. The Competition is governed by English Law, and any dispute between us and you regarding the Competition will only be dealt with by the English courts, but if you live in a part of the United Kingdom other than England, the applicable law of that part of the United Kingdom will govern and any dispute will only be dealt with by the courts there.

The prize

- The prize will include four tickets to the Saturday session of the 2020 British Championships at M&S Bank Arena, Liverpool (18th April 2020). Travel to and from the event, and accommodation will not be included. Tickets will be available to pick up on the day of the event.
- Tickets cannot be transferred to a second party, or exchanged for a different day. No cash substitution or alternative tickets will be provided if the winner cannot attend the session. The winner and three guests (at least one of whom must be at least 18 years old on the date of the event) must

- be able to attend on this date and consent to our spectator regulations and ticketing terms and conditions.
- 3. The winner agrees not to sell, offer to sell or use the prize for any commercial or promotional purpose (including placing the prize on an internet auction site).
- 4. For the winner's name and county please send an SAE, stating the name of the Competition to Marketing Manager, British Gymnastics, Lilleshall National Sports Centre, Newport, Shropshire, TF10 9AT.

The winner

- The winner's name and county will be published on our website and social media accounts and we will confirm this information to anyone who writes to us in accordance with section 4 of "the prize" section above.
- The winning entrant will be expected to assist with promotion of the mascot.
- 3. The winning entrant agrees to comply with a reasonable request from us to provide a photo of themselves with their prize for advertising and publicity purposes without additional remuneration.

The design

- The winning entry is the inspiration for, but not the final design for the mascot. We reserve the right to change the chosen entry and story in any way to ensure the mascot design is suitable for purpose.
- 2. The winning entry will be developed by the appointed mascot production company and a professional illustrator.
- 3. Entries must be original and not a copied character.
- 4. By submitting your entry and in consideration of our agreeing to allow you to enter the Competition (the receipt and sufficiency of which is acknowledged by you) you agree to:
 - a) assign to us with full title guarantee all Intellectual Property Rights in your competition entry and waive all moral rights to such entry; and
 - at our request, use all reasonable endeavours to promptly execute such documents and perform such acts as may reasonably be required to give effect to this assignment.
- 5. You further confirm that your competition entry does not infringe the Intellectual Property Rights of any third party and that you have not by act or omission caused or permitted, and are not aware of, anything which might jeopardise the assignment, registration, enforceability or application for registration of the Intellectual Property Rights in the competition entry.
- 6. For the purposes of these terms and conditions, "Intellectual Property Rights" means: any and all copyright, rights in inventions, patents, knowhow, trade secrets, trademarks and trade names, service marks, design rights, rights in getup, database rights and rights in data, domain names and all similar rights and, in each case: (a) whether registered or not; (b) including any applications to protect or register such rights; (c) including all renewals and extensions of such rights or applications; (d) whether vested, contingent or future; (e) and wherever existing.

Privacy

- Entrants' personal data will only be processed by us for the purposes of administering and assessing this Competition in accordance with the above terms and conditions.
- 2. Except for the winning entry, all personal information contained in entries will be deleted within six months of the competition closing date.
- We have a legitimate interest to publish information about the winner for promotional purposes as set out in "the winner" section above and to comply with Advertising Standards Authority requirements.
- 4. Entrants can object to their personal information being used for the above purposes by contacting us at customersupport@british-gymnastics.org. Notwithstanding any objection, we must still provide information about the winner to the Advertising Standards Authority upon request.
