**Competition Terms & Conditions – 2020 British Gymnastics Christmas Countdown competition, to win an item of clothing from the British Gymnastics Official Shop**

## **PART A – INTRODUCTION**

1. These terms and conditions apply to the 2020 British Gymnastics Christmas Countdown competition promoted on British Gymnastics' Facebook and Instagram accounts.
2. The promoter of the competition is British Gymnastics. British Gymnastics' company number is 01630001, and its registered office is at Ford Hall, Lilleshall National Sports Centre, Newport, Shropshire, TF10 9AT.

## **PART B – KEY FACTS**

3. Entrants: Entrants to the competition should be aged 16 years or over.
4. Staff: All British Gymnastics Directors, staff and their immediate families are ineligible for entry into the draw.
5. Prize: The prize offered in this competition is one clothing item of the winner's choice from the British Gymnastics Official Shop, up to £35, excluding all leotards. Prizes will be confirmed in the British Gymnastics channels and are subject to change.
6. Entry: Entry to the competition runs from Friday 4<sup>th</sup> December 2020 when it is posted on Instagram and Facebook, to Monday 7<sup>th</sup> December at 12pm. To enter you will need to follow the instructions where the competition is published.
7. Competition draw date: The winners name will be drawn at random from the data provided, on Monday 7<sup>th</sup> December 2020. The winner will be asked to contact British Gymnastics either by direct message (Instagram) or via email (Facebook) to [communications@british-gymnastics.org](mailto:communications@british-gymnastics.org).
8. Entrants will have to comment on the British Gymnastics competition post on either Instagram or Facebook. The comment will need to include an item of clothing they would like to win from the British Gymnastics Official Shop. This item cannot exceed £35 and excludes all leotards. This competition is to win an item of British Gymnastics clothing only.

## **PART C – OTHER TERMS AND CONDITIONS**

9. The instructions provided on the website or anywhere else in British Gymnastics channels, form part of the terms & conditions of this competition. In the event of a conflict, these terms & conditions take precedence.
10. Only one entry per person will be admitted to the draw.
11. British Gymnastics reserves the right to verify the eligibility of entrants. British Gymnastics may require such information as it considers reasonably necessary for the purpose of verifying the eligibility of an entry and the prize may be withheld until and unless British Gymnastics is satisfied with the verification.
12. The winner will be selected at random from all eligible entries received. Winners will be notified by British Gymnastics within 5 days of the draw date (7<sup>th</sup> December 2020) by commenting on the competition entry. 13. Entrants' personal data will be processed for the purposes of administering and assessing this Prize Draw.
