in each case by no later than 48 hours prior to the start of the EGM, i.e. by **18:30hrs on Tuesday 9<sup>th</sup> March**.

- Please note that it will not be possible to submit your vote at the EGM or after 18:30hrs on Tuesday 9<sup>th</sup> March 2021. Any votes received after this time will not be counted. Please also note that there is no facility for withdrawing your vote once it has been submitted.
