Appointment of Auditors

The current auditor Chris McGlashan is happy to continue, proposed Richard Neely and seconded by Jim Franklin. The meeting accepted the appointment.

Setting of Annual Affiliation Fee:

It was noted that although the fee had remained unchanged at last year's AGM at £46, in fact only £45.00 had been charged. It was agreed that the fee of £46 remain for 2012. Proposed by Paul Lipton, seconded by Dean Walters & accepted by the meeting.

Technical Reports: Those reports received were handed out or read

Reports were received from the following disciplines: Acrobatic; General; WTC; Rhythmic & coach education

ACRO & TUMBLING REPORT

We currently have 9 Acro / Tumbling Gym Clubs in the region, 8 of which are GymMark accredited and a further 2 or 3 clubs competing in Tumbling only.

Competition Report - Once again we held 4 competitions in the region and have the same planned for the forthcoming year. Entries to all competitions were high and we have seen some fantastic results at national and international level.

2010 saw East Midlands produce National Champions in both Acro and Tumbling at the NDP finals. Congratulations to the L4 men's group and L4 mixed pair from Loughborough Acro and Charlie Peat from Erewash (Elite 1 11/12yrs tumbling). We also picked up 2 silver and 3 bronze medals at the championships.

Our tumblers from Derby City also had great success at the British Tournament, taking 3 of the titles. - Greg Townley rounded off a great year when he became the World Age Group Tumbling Champion (Age 13/14) at the championships in Metz.Representing Great Britain he finished with a score of 34.00, 1.5 points ahead of his nearest rival from Russia. He was also crowned Derbyshire Junior Sportsman of the Year 2010.

Coach & Judge Development - Since the last AGM, 2 judges passed their National Acro Judging Exam with a further 1 passing the theory paper (awaiting date for practical assessment). All current judges who haven't upgraded their qualification in the current cycle need to attend an update course in order to keep a valid qualification. This is planned for 16 July at Rushcliffe and details will shortly be issued on the EMGA website. We are also holding a Regional Judging course on 17 July and a club judge early September, with the exam planned to take place in October. A level 1 acro coaching course is booked to start in march at Derby City Gymnastics Club. This will result in approximately 8 new coaches to region.

GENERAL GYMNASTICS REPORT

2010 was a successful year.

Four competitions took place all these were very well attended with approximately 600 gymnasts taking part.

In 2011 we will be holding 5 competitions

- The U8 yrs floor & vault on Sunday 20th March Chesterfield (this has 147 entries).
- Over 8 Floor & Vault Primary 2 on Sunday 12th June Chesterfield.
- Over 8 Floor & Vault Primary 1, Advanced and Advanced plus on Sunday 26th June New College Leicester.
- Over 8 four piece Primary 2 boys & girls on Sunday 13th November New College Leicester.
- Over 8 four piece Primary 1 & Advanced boys & girls on Sunday and Advanced plus for girls only 27th November New College Leicester.

The last 2 competitions were well attended in 2010 and have be made two competitions in 2011. In the four piece competition the boys will use parallel bars and the girls use the beam.

WOMENS REPORT

Another successful year For WA in the East Midlands. Our women gymnasts have capitalised on Becky Downie's achievements and we have had Gymnasts from the region at the worlds and the commonwealth Games and not to mention countless internationals.

As a region we still have gymnasts competing at all levels both in Elite and Challenge cup. This is an impressive result for such a small region. It also reflects on the high quality of our coaches. There is a real visible improvement in the overall quality of our gymnasts. A trend, we must keep up. We have some real depth to our discipline and we must continue to invest in our coaches to maintain the standards we now expect.

In our competitions we have the new competition team of Marie and Vicky who have done a sterling job of organising the competitions in 2010. Our competitions continue to grow in size and are a real show piece for women's artist gymnastics. New college facility is holding up well and we can see some promising developments to increase capacity in 2011.

Jenni has settled in to judge convenor and technically we are as strong as in previous years. We have struggled to find a chair for the WTC and this must be a priority going forward in 2011.

As with 2010 we will be looking to recruit support from each of the counties to complete the WTC. We cannot continue with just the same core people. If we can't fill the TC then we will have little choice but to employ paid support staff and levy the cost back onto the clubs/gymnasts.

Finally many thanks to my committee who have delivered yet again.

RYTHMIC REPORT

General - The change in the competition format for Rhythmic, with the emphasis being put on group/team work has had a major impact on the clubs in the Region. It is hard to keep gymnasts enthusiasm, with very few competitions for them to enter. One of the ways we are achieving this is by offering dance & acro classes instead of the Regional Training session and opening it up to all gymnasts in the region whatever their level.

The region has lost two of its top gymnasts over the last year, both to Birmingham City, Frankie Jones and Catherine McNicol.

A Gym Jamboree was organised by Northampton with help from Billings and NVRGC with dance and acro workshops for all ages and abilities followed by games then a display where girls performed group, duet and trio routines. This was a big success and we are hoping to persuade Jenny Bott to make it an annual event.

NVRGC were the only club from the region who entered a team in the newly established U11 National Group League. They competed 2 routines, Rope & Free, over 3 competitions finishing 5th overall, with their highest placing being 4th at the British Group Championships.

EVGC Rhythmic took part in the Christmas Ice Show at Nottingham Arena during December, this went very well and they hope to be asked back in 2011.

International - Hannah Dulston (EV) competed for Great Britain along with four other gymnasts from around the Country at the 30th Rhythmic World Championships in Moscow as part of the RG Group. This group is very much in its infancy and hopes to compete at the 2012 London Olympics

Results - Zonal grades were hosted this year by the West Midlands, and the EM Regional Championships were incorporated in Nene valley's novice competition 'The Rose Cup'. Next year the event will be hosted by the East Midlands at Weavers Leisure Centre Wellingborough.

COACH EDUCATION REPORT

Despite a few initial small issues the transfer of Awarding Body Status for coaching qualifications from British Gymnastics to 1st4Sport has been successful. All Level 1 and Level 2 courses are provided as a 1st4Sport recognised centre by the region.

Level 3 and above courses / modules are organised nationally by British Gymnastics but are advertised on the regional website.

2010 saw 14 Level 1 courses provided by the region with attendance from 132 candidates and 3 Level 2 courses with 32 candidates.

Assessments in 2010 saw 94 new Level 1 coaches qualify (71 from East Midlands) and 24 new Level 2 coaches (22 from East Midlands).

Regional Workforce

• Recent tutor training for Time to Listen tutors has resulted in the region now having 3 qualified tutors and one who is undertaking training

- 3 new tutors have completed their initial training and are now working towards becoming fully qualified
- Future workforce requirements have been forwarded to British Gymnastics ready for the next tutor training programme
- 3 new assessors have completed training, allowing them to assess candidates
- 2 assessors have completed their professional discussion with the external verifier and have therefore gained the full IAPS qualification
 - o the remaining candidates who have completed their 2nd practical assessments are working on completing their portfolio's ready for their professional discussion
 - o two assessors still have to complete their 2nd practical assessments
- Following the withdrawal of providing Safeguarding & Protecting Children courses by British Gymnastics, the Region has registered with ScUK in order that it can now provide them. The first course was run in Leicestershire in December
