

JUDGING SELECTION POLICY

- Judges ensure Log book is up to date and signed off; irrespective if the competition is Club, County, Regional or National.
- All Categories of judges will be given credit for activities such as delivering/assessing courses, delivering workshops. We would ask that specific events be signed off in your log book by the Event Organiser.
- Brevet Log books being issued by UEG with candidate's badge and certificate.
- Brevet Judges require to have judged a minimum of 3 competitions in any one year, one of which being either a National qualifying event, the British Championships and/or International Cup. This doesn't solely determine selection for European events, more it recognises the work rate and who is asked to revalidate next cycle.
- National Judges or those wishing to upgrade to National Judge require to have judged at a minimum of two Regional competitions and one National event in any one cycle, as well as being involved in local or regional club organisation.
- Regional Judges or those wishing to upgrade to Regional Judge require to be active at local or regional competitions either judging, coaching or in an administrative roll.

Europeans Championships – Brevet Judges only.

The final selection to appoint brevet to the UK delegation for a European Championships (ECH) will be undertaken by the Selection Panel, consisting of the Performance Manager, NTCC and NJC. Where one of these three Panel members is up for selection, an unconflicted member of the TGTC will be appointed in their place (selected by the TGTC).

The selection panel will aim to make their selections in the best interests of British Gymnastics and GBR.

Selection will be based upon the following factors:

1. **AVAILABILITY.** This will be gained by the NJC [this may also include any test events prior to ECH].
2. **CONFLICTING ROLES.** For example if a judge is required to act as coach, gymnast or other staff member at the ECH as dual roles are not permitted within the regulations.
3. **ACCEPTANCE AND ADHERENCE** to BG policies which also includes being politically astute and a responsible representative of British Gymnastics.
4. **JUDGING HISTORY.** Have met or exceeded the annual requirement of competitions judged in any one year (see note above).
5. **ECH HEAD JUDGE POSITIONS.** Typically this would be the higher level Brevet judges as determined by the UEG Brevet exam results.
6. **ECH EXPERIENCE.** If there is an opportunity to send judges to gain experience and further their professional development and expertise, priority will be given to likely return of investment (short and long term).

British TeamGym Events – All judges

[Panels will be selected by the NJC in consultation with the TGTC and TG Events Panel].

- **HEAD JUDGES,** subject to availability i.e. E1 C1 and D1 or DC1 for National Qualifiers and British TeamGym Finals, these positions will be manned by Brevet and/or National Judges.
- **ALL OTHER PANEL POSITIONS:** Subject to availability, these positions will be manned by National and/or Regional Judges. Club judges will be encouraged to sit on panels for experience.

NOTE: For all other non-selection events, panels will be assembled more randomly to allow a broad experience base and give judges the opportunity to gain exposure to other pieces of apparatus and roles.
