

## Competition Terms & Conditions – Win a day at Lilleshall National Sports Centre!

Prize to win a day, personalised for your gymnastics club, at Lilleshall National Sports Centre, the home of British Gymnastics.

### PART A – INTRODUCTION

1. These terms and conditions apply to the competition hosted at <https://www.british-gymnastics.org/news-and-events/news/latest-news/8765-win-your-club-a-day-at-the-home-of-british-gymnastics> and promoted in the bi-weekly e-newsletter GymBlast, in the bi-weekly e-newsletter Community News, and on British Gymnastics social media channels (Twitter, Facebook and Instagram).
2. The promoter of the competition is British Gymnastics. British Gymnastics' company number is 01630001, and its registered office is at Lilleshall National Sports Centre, Newport, Shropshire, TF10 9AT.

### PART B – KEY FACTS

1. Entrants: Entrants who complete the entry details on the webpage <https://www.british-gymnastics.org/news-and-events/news/latest-news/8765-win-your-club-a-day-at-the-home-of-british-gymnastics> must be a staff member (Coach, Secretary or Welfare Officer) at their club.
2. Entrants must be aged 18 or over and provide a British Gymnastics membership number.
3. The entrant will be completing the entry form on behalf of the British Gymnastics club they are registered to.
4. The club that the entrant is entering on behalf of, must have completed their British Gymnastics membership for the 2019/20 year prior to Friday 1st November 2019. Failure to have done so will mean the entry will be discredited.
5. The club that the entrant is entering on behalf of must meet the British Gymnastics Membership Rules at the time of entry. Failure to do so will mean the entry will be discredited.
6. Any club that, at the point of entry, is suspected and is under investigation for, or already has sanctions in place for, a breach of Membership Rules or any British Gymnastics Policies or Procedures will be deemed ineligible to enter and the entry will be discredited.
7. Staff: All British Gymnastics Directors, staff and their immediate families are ineligible for entry into the draw.
8. Prize: The prize offered in this competition is a day at Lilleshall National Sports Centre for one club, the opportunity to have a session in one of our new gyms, lunch and transport to and from Lilleshall (maximum 50 people).
9. Entry: Entry to the draw commences from November 1st 2019, closing on November 31st 2019.
10. Entry: Only one entry per person/club. Your club name will then be entered in to the draw.
11. Competition draw date: The winning club will be drawn on Saturday 25th January 2020, at the British Gymnastics National Awards.
12. The day at Lilleshall will take place on a day mutually agreed by both British Gymnastics and the winning club.

## **PART C – OTHER TERMS AND CONDITIONS**

1. The instructions provided on the website or anywhere else in British Gymnastics channels, form part of the terms & conditions of this competition. In the event of a conflict, these terms & conditions take precedence.
2. Only one entry per person/club will be admitted to the draw.
3. No purchases are necessary for entry into the competition.
4. British Gymnastics reserves the right to verify the eligibility of entrants. British Gymnastics may require such information as it considers reasonably necessary for the purpose of verifying the eligibility of an entry and the prize may be withheld until and unless British Gymnastics is satisfied with the verification.
5. The winning club will be selected at random from all eligible entries received. Winners will be notified by British Gymnastics either by the email address or phone number provided at registration.
6. Entrants' personal data will be processed for the purposes of administering and assessing this Prize Draw only.
7. The name of the club that has won will only be published with the consent of the that club.
8. If British Gymnastics is unable to contact the winner within 14 days from initial notification, or if any prize is unclaimed or declined within a reasonable period, the prize shall be deemed as unclaimed or unaccepted and a supplementary winner may be drawn at British Gymnastics' discretion.

British Gymnastics reserves the right to suspend, cancel or amend the promotion and/or review and revise these terms and conditions at any time without giving prior notice if circumstances make this unavoidable.
