Representation Selection Policy

Section 1 Event

Event: Northern Europeans 2014
Venue: Denmark
Dates: 12th – 14th September 2014

Section 2 Eligibility for Selection

- Gymnasts must be born in Northern Ireland
- Gymnasts must have a Parent who was born in Northern Ireland
- Gymnasts must have a Grandparent born in Northern Ireland
- Gymnasts must hold membership with a National Governing Body for Gymnastics

Section 3 Criteria for Selection to Gymnastics Northern Ireland Women's Teams

- Top 5 Gymnasts with highest accumulative scores over 2 trials on each apparatus piece will be selected
- 4 Gymnasts from the 5 will compete on each apparatus at the event – this decision will be made after podium training at the event
- All Gymnasts must be ratified by the GNI WTC

Section 4 Policy

- (a) This Selection Policy has been agreed by the Women's Technical Committee
- (b) Failing an agreement by WTC to ratify an element of the policy, the specific issue will be brought to the attention of the GNI Management Committee who will decide the outcome. WTC will then implement.
- (c) The agreed Gymnastics Northern Ireland Selection policy (plus the Expression of Interest Form and Financial Agreement, where applicable) will be issued to clubs on Monday 16th June 2014
- (d) The Expression of Interest Form and the Financial Agreement will have a closing date of 26^h June 2014

Section 5 Trials

- (a) The Gymnasts selection to the Gymnastics Northern Ireland NORTHERN EUROPEANS Team will be by a performance trial over 4 apparatus pieces
- (b) The Gymnasts with the highest score on each apparatus piece over 2 trials will be selected to represent the Gymnastics Northern Ireland Northern Europeans Team on that apparatus piece
- (c) Trial Dates are:

Trial 1 – 7th July 2014 – Salto Gymnastics Centre. Lisburn @ 3.30pm

Trial 2 – 10th July 2014 – Salto Gymnastics Centre @ 12.30pm
- (d) All trials must follow FIG/UEG rules; the use of soft landings or the presence of a coach may be approved in special circumstances on skills above a certain value. This must be submitted to the WTC for approval by the Club Coach
- (e) Gymnasts must obtain selection criteria scores in 2 of the 2 trial competitions
- (f) Achieving a Performance Standard/score gives no right or guarantee of final Team selection. The final Selection will be made by the WTC after podium training in line with FIG rules (12 hours before start of event)
- (g) Post selection, all gymnasts must maintain standards and if not a gymnast could be de-selected by the National Squad Coach/Performance Manager

- (h) A gymnast's training may be viewed at any point by the National Squad Coach /Performance Manager.
- (i) The Gymnast and Club Coach will be notified of any decision and the reasons for the decision to de-select
- (j) A tolerance score of a 0.5 is allowable for selection. Gymnasts may have an allowance of a 0.5 tolerance under the official selection score however they must achieve a minimum of 1 score within the tolerance to be considered eligible for selection
- (k) In the event of a tie the Gymnast with the highest Bars score will be selected

Section 6 Judging Panels for Trials & Event Judge

- (a) A Judging Panel with at least 1 brevet Judge on the up to date cycle will be convened for all trials
- (b) The Judging Panel will reflect a FIG panel in respect of numbers making up the panel and processes used for scoring
- (c) Judges should be rotated for each apparatus piece so that all available Judges are used
- (d) Judges to present scores before the end of each rotation – Head Judge for the day must ensure that all scores are recorded and displayed to Gymnasts and Coaches

Section 7 Event Coach Appointment

To be considered as an event Coach the Coach must fulfil the following criteria;

- Be a member of a National Governing Body
- Hold appropriate Insurance cover for Coaching Performance Gymnastics
- Must be knowledgeable in and fulfil FIG/UEG regulations for competitions
- The coach must have experience and be able to cope under stress, be competent and knowledgeable
- Submit an Expression of Interest Form and Financial Agreement to Gymnastics Northern Ireland WTC Secretary – alsion@abbeygymnastics.com by the stated deadline

- Have completed the Garda/Access NI vetting process with Gymnastics Northern Ireland
- If selected must complete and sign all international travel forms including “Coaches Code of Conduct” prior to travelling.
- If selected attend any pre training camp and to stay for the full duration of event unless otherwise agreed with WTC

The following criteria will be considered when selecting Event Coaches;

- Medal - coach with any gymnasts most likely to medal
- Final - coach with any gymnasts likely to be in a final
- A coach with the most gymnasts competing
- Ability to coach all gymnasts regardless of tariff /routines

Section 8 Performance Management

- The nominated Event Coach, Sun Jie will have the responsibility for making all tactical decisions in team/individual situations
- Sun Jie will communicate effectively with all Gymnasts and Coaches regarding all aspects of the event training, preparation, podium protocols, competition protocols etc.
- All coaches will be expected to work with and carry out instruction from the Event Coach, Sun Jie
- Both event Coaches will work as a team and agree specific responsibilities before event training commences
- Event Coaches will provide Gymnasts and personal coaches with an event plan for podium training and competition protocol eg. Order of warm-up and compete

Section 9 Expression of Interest Form

- (a) Fully completed Expression of Interest Form must be completed by the club of any intending gymnasts to participate in the trial for team selection. Completed form should be returned by the club to WTC Secretary,

- (b) Expression of Interest form must be received before stated deadline to make Gymnast eligible for selection

Section 9 Financial Agreement

- (a) For International Events, Gymnast/Parents/Guardians must complete the Financial Agreement and must have complied with the terms of any prior financial agreement and repaid all monies owing by Gymnast to Gymnastics Northern Ireland.

- (b) Completed form returned (with the Expression of interest form) by the Club must be received by the WTC Secretary by the stated deadline.

Section 8 Appeals Procedure

- (a) Any competition appeal must be in line with F.I.G. rules - <http://www.fig-gymnastics.com>
- (b) Any selection appeal can only be submitted for a non-selected gymnast if the process within the Gymnastics Northern Ireland selection policy has not been followed.
- (c) Appeals must be made in writing no later than 24 hours of the last trial date and forwarded to the WTC Secretary, alison@abbeygymnastics.com
