DECLARATION of INTENTION TO TRIAL

European Championships 2021

All partnerships must declare their wish to participate in the Selection Trials by completing the form below with the Partnership Category, Gymnasts Names, Name of Club and Personal Coach and emailing it to the Performance Service Officer by **Tuesday 13:00hrs 6th July 2021**.

Partnerships who fulfil one or more of the following criteria will be eligible to trial for the 2021 European Championships:

- a) Represented Great Britain at the WAGC or WCh 2021 to include those who have changed Age Group
- b) Partnerships who trialled for the WAGC or WCh 2021
- c) Gymnasts who were on the elite exemption register but chose not to trial for WAGC or WCh 2021

Partnerships not covered by the above can submit a request to trial with supporting evidence by Tuesday 13:00hrs 6th July 2021. These will be considered for Trial by the National Coach with a final decision on attending the selection events no later than Friday 16th July 2021.

The National Coach may elect to invite up to five partnerships per discipline to attend the Selection Events. In all cases partnerships must be considered to be competitive and capable of obtaining the benchmark score at the Selection Events.

Confirmation of gymnasts selected to trial will be published by **Friday 16th July** at the latest. To confirm your gymnasts' acceptance to trial you will be asked to make the trial payment at

this point, which is £25 per gymnast. Please make this payment by BACS to the bank details on the bottom of this letter, with a clearly labelled reference.

When submitting entries for a British Gymnastics selection event the onus is on the club and the coaches to:

- ensure that the coaches attending are qualified to the level of the participants' performance
- ensure that all parents/guardians are aware of this policy and wish for their son or daughter to be entered and are available for selection
