<p><b>Competition Format</b></p>	<ul style="list-style-type: none"> <li>• FIG Competition I &amp; II</li> <li>• Competition I (CI): Balance, Dynamic and Combined qualification for Competition II (CII)</li> <li>• Competition II: Final (Top 6 - 8 with a maximum of 1 per Federation)</li> <li>• Team Ranking – Scores from CI will count for the team ranking as per the FIG Technical Regulations point 3.3.3</li> </ul> <p>In accordance with the current FIG Technical Regulations, Statutes, Code of Points (CoP) and Table of Difficulty (ToD) 2017-2020</p>
<p><b>Performance Targets</b></p>	<ul style="list-style-type: none"> <li>• Qualify 2 or more partnerships for Competition II</li> <li>• 1 or more medals in Competition II</li> </ul>
<p><b>Eligibility</b></p>	<ol style="list-style-type: none"> <li>1. Gymnasts are eligible for consideration provided they are:             <ul style="list-style-type: none"> <li>• a British Citizen holding a British passport</li> <li>• a minimum of 15 years old in the year of competition</li> <li>• a current British Gymnastics member in good standing</li> <li>• In possession of a Gymnast Licence held with FIG</li> </ul> </li> </ol>
<p><b>The 'Team'</b></p>	<ol style="list-style-type: none"> <li>1. The 'Team' means the individuals selected by British Gymnastics and includes gymnasts/partnerships, coaches, medical support personnel, judges, Team Leaders, Heads of Delegation and any associated member of the Performance Sport Programmes' staff to represent Great Britain at the Championships.</li> </ol>
<p><b>Selection Panel</b></p>	<ol style="list-style-type: none"> <li>1. Following the completion of the Designated Selection Events listed within this Policy, the National Coach will consult with the Performance Manager. Account will be made for any relevant input deemed necessary from the medical staff to discuss the nomination of the gymnasts. The Performance Manager will consult with the other members of the Selection Panel (the Technical Committee Chairman and the National Judge Co-ordinator) to agree the nominations.</li> <li>2. The nominated gymnasts/partnerships and coaches will be those who meet the nomination criteria, and:             <ol style="list-style-type: none"> <li>a) In the opinion of the National Coach and the Selection Panel, are most able to achieve the targets listed within the section 'Performance Targets'.</li> </ol> <p style="text-align: center;">OR</p> <ol style="list-style-type: none"> <li>b) In the opinion of the National Coach and the Selection Panel, deem competing at the event a suitable performance development opportunity.</li> </ol> </li> <li>3. Following the above process, the Performance Manager will forward a list of nominated partnerships and coaches to the Approval Panel for their review.</li> </ol>

<b>Approval Panel</b>	<ol style="list-style-type: none"> <li>1. A British Gymnastics Approval Panel, comprising the Performance Director and the Head of Performance Programmes will consider the nominations of the partnerships and coaches received from the Selection Panel and ratify these as appropriate.</li> <li>2. In the event that the Selection Panel submit insufficient partnerships than the available team places, the Approval Panel have the opportunity to make referral back to the Selection Panel for their reasoning at which point their list of nominations may be amended.</li> <li>3. The Approval Panel will confirm the selection of the team / partnerships with the Performance Manager no later than <b>Friday 23 February 2018</b>.</li> </ol>
<b>Appeals</b>	<ol style="list-style-type: none"> <li>1. Appeals can only be submitted by the gymnasts from the non-selected partnership on the basis that the process outlined within this Selection Policy has not been adhered to.</li> <li>2. <b>Designated Selection Event</b>	<ol style="list-style-type: none"> <li>1. The selection policy described below applies to the following selection events: <ol style="list-style-type: none"> <li>1. <b>Selection 1 – British Championships 17/18 February 2018 – Fenton Manor</b></li> </ol> <p><b>All Categories:</b> 1 balance routine, 1 dynamic routine, 1 combined routine</p> <p><i>NB. Any gymnast who is ill or injured prior to or during the Designated Selection Event above, must provide immediate written authentication of the injury or illness by a registered medical practitioner or chartered physiotherapist. This documentation must be submitted to the Programme Manager.</i></p> </li> </ol>
<b>Nomination to Trial Process</b>	<ol style="list-style-type: none"> <li>1. All partnerships are required to register to trial. This will be by letter to the Programme Officer – <b>deadline midnight Friday 1<sup>st</sup> December 2017</b> (see form at the end of this policy).</li> <li>2. Partnerships who fulfil one or more of the following criteria will be eligible to trial for the 2018 World Championships: <ol style="list-style-type: none"> <li>a) Represented Great Britain at the 2017 Senior or Junior European Championships, to include those who have changed Age Group.</li> </ol> <p>NB. If there is a change of 1 partner from the pair or group that competed at the European Championships, the National Coach will make a judgement of their eligibility to trial.</p> <ol style="list-style-type: none"> <li>b) Achieved an average score for Execution from all 3 routines performed at the 2017 Acrobatic Pat Wade Classic of 8.30 before been they are doubled.</li> </ol> </li> <li>3. Partnerships who do not meet either of the criteria above must support their registration to trial with full results from a recent competition or provide other evidence to justify their registration. This will be reviewed by the National Coach with a final decision on attending the selection events no later than Friday, <b>8<sup>th</sup> December 2017</b>.</li> <li>4. The National Coach can invite for Trials Partnership with no competition results if: <ol style="list-style-type: none"> <li>a) Based on his observations and judgement this partnership could achieve a high standard of performance;</li> <li>b) He advised the partnership's Coach to skip competitions to insure uninterrupted preparation for quality Performance. Such an agreement is not a promise for selection to Trial.</li> </ol> </li> <li>5. The National Coach may elect to invite up to five partnerships per category to attend the Selection Events. In all cases partnerships must be considered to be competitive and capable of obtaining the benchmark score at the Selection Events. In this situation the</li> </ol>

	<p>Performance Manager will notify the primary coach and request that a declaration of intention to compete is submitted by the deadline of midnight <b>Friday 1st December 2017</b>.</p>
<p><b>Nomination Process</b></p>	<ol style="list-style-type: none"> <li>1. A maximum of two partnerships per category may be nominated for selection on the basis of achieving the best result for Great Britain.</li> <li>2. Nomination for selection will be conducted as follows: <ul style="list-style-type: none"> <li><b>Selection</b></li> <li>a) Execution Scores from the three routines at the Selection Event will be averaged. If this average score is equal to or higher than the benchmark score of 8.50, the Partnership can be Nominated for Selection.</li> <li>b) The selection event results do not result in automatic nomination for selection in the order of the Final Overall Ranking but will be used in the National Coach and Selection Panel considerations.</li> </ul> </li> <li>3. The Selection Panel may nominate partnerships for allotted places under the following conditions: <ul style="list-style-type: none"> <li>a) The partnership has achieved the benchmark Execution score of 8.50.</li> <li>b) The partnership is deemed by the National Coach and Selection Panel as capable of qualifying for Competition II.</li> <li>c) The National Coach and Selection Panel deem competing at the event a suitable performance development opportunity for the nominated partnership.</li> <li>d) Allotted places are not guaranteed and the use of such places is not open to appeal.</li> </ul> </li> <li>4. By entering the selection process, gymnasts and personal coaches agree to be bound by the provisions of this policy.</li> <li>5. Nominated partnerships, including any reserve(s), will be expected to maintain readiness to compete and may be requested to prove this during any of the club visits made by the National Coach prior to the Championships.</li> <li>6. Nominated gymnasts and coaches must also agree to observe all obligations outlined within the British Gymnastics' Gymnast Agreement 2017 – 2021 and any subsequent Codes of Conduct adopted by British Gymnastics.</li> <li>7. Team Coaches will be nominated based upon the following criteria: <ul style="list-style-type: none"> <li>i. The number of available accreditations.</li> <li>ii. The needs of the team.</li> <li>iii. The ability to operate as part of a team, to be considered and measured in situations of responsibility and pressure, to work with their own gymnasts as well as others, and to support all team members.</li> <li>iv. High Performance Coach qualification, or equivalent, with a current DBS and Safeguarding and Protecting Children certificate.</li> <li>v. Previous international experience and performance.</li> <li>vi. Commitment required meetings, pre-event training, and the selection event.</li> </ul> </li> </ol>
<p><b>Injury &amp; Replacement</b></p>	<ol style="list-style-type: none"> <li>1. In the event of injury and/or the need for replacement, a partnership or gymnast may be called upon to join the Team at any time.</li> <li>2. Once the Team selections have been confirmed by the Approval Panel and announced, all selected gymnasts (including the reserves) must agree not to withhold any</li> </ol>

information on training fitness, injury status or illness that could affect training or competition readiness at any time up to the conclusion of the Championships.

3. All selected gymnasts must declare medications they are taking, in particular the use of any restricted medications, and submit these in writing for the attention of the Performance Manager.
4. A gymnast / partnership or coach may be removed from the Team in the event of non-compliance in training, a breach of responsibility to the Team or a violation of the Codes of Conduct adopted by the Team. Prior to removal the gymnast / partnership or coach must be presented with the opportunity to attend a removal interview with the Head of Delegation (or their appointed representative) and where possible one other independent person. Written justification must be provided for all removals by the Head of Delegation. Decisions on these matters are not open to appeal.
5. Once selected until departure for the competition, where a gymnast / partnership is unable to train for a significant period time, where a significant period of time is defined as seven continuous days or more, the primary coach must declare this information to the Performance Manager.
6. At any stage following the selection announcement and prior to departure to the competition, should any partnership / gymnast fail to reach performance expectations in training or competition, the National Coach may recommend de-selection to the Performance Manager / Selection Panel. If supported by the Selection Panel the case will be referred to the Approval Panel who will consider this recommendation, provide an opportunity for the gymnast / partnership to make a counter-argument, and then pass judgement. Written justification must be provided for all removals. Decisions on these matters are not open to appeal.
7. At any stage following the arrival of the Team at the competition and during the event, should any gymnast/partnership fail to reach performance expectations in training or competition, the National Coach may recommend de-selection to Head of Delegation. The Head of Delegation will consider this recommendation, provide an opportunity for the gymnast/partnership to attend an interview to make a counter-argument, and then pass judgement. Written justification must be provided for all removals. Decisions on these matters are not open to appeal.
8. In the event there is a breach of responsibility to the Team or a violation of the Codes of Conduct adopted, during or after the competition, i.e. the banquet and prior to returning to the UK, depending on the circumstances, gymnasts or officials may receive a penalty. In the case of a gymnast this will impact on present or future partnerships they are in until the expiry date of the penalty imposed.
9. At any stage following the selection announcement, should there be a doubt over the ability of a gymnast / partnership to compete to the best of their ability due to an injury or illness, the following procedure will be adhered to:
  - a) The gymnast will be referred to British Gymnastics' a designated Medical Officer to undergo a medical examination to determine their fitness to participate. Initially this will be based on an assessment of whether or not the injury, illness and /or medical condition is such that the gymnast is physically unable to compete or is at risk of causing medical harm to themselves, or endangering other competitors, officials or spectators.
  - b) If the gymnast passes the initial medical examination carried out by the Medical Officer but British Gymnastics still has concerns over whether or not the gymnast is able to compete to the best of their ability due to the underlying injury, illness or

	<p>condition, the gymnast will be required to undertake British Gymnastics' designated "Fitness Test".</p> <p>c) The Fitness Test will require the gymnast to perform a minimum of one routine with their partnership, to members of the Selection Panel and the National Coach at a set time and location. The panel will analyse the routine(s) and must be in agreement that the partnership is capable of achieving the performance standards expected by the time of the competition and alternative partnerships seen at the Selection Events do not offer a better alternative.</p> <p>d) In the event that a gymnast fails to complete the Fitness Test to the required standard, they will be removed from the Team, a decision that is not open to appeal.</p> <p>10. In the event that a gymnast within a partnership changes after the announcement of the team, the new partnerships must first be declared to the Performance Manager. A change of partnership may be considered under the following circumstances:</p> <p>a) The new partnership is able to demonstrate all three routines and will be 'assessed' by the National Coach, with a minimum of one or more of the Selection Panel, at a set time and location (TBC).</p> <p>b) The panel must be convinced and in agreement that there is not a more viable partnership seen at the Selection Events and that the replacement gymnast(s) and partnership is capable of achieving the Performance Targets set within this policy.</p> <p>11. Any replacement partnership(s) will be made by the National Coach and Performance Manager on the basis of the needs of the Team. Decisions on these matters are not open to appeal.</p>
<b>Team Organisation</b>	<ol style="list-style-type: none"> <li>1. There will be a mandatory Team training camp 17<sup>th</sup>/18<sup>th</sup> March 2018 at Lilleshall National Sports Centre.</li> <li>2. If they have not already done so, all gymnasts within the Team will be required to sign and comply with British Gymnastics' Gymnast Agreement 2017 – 2021</li> <li>3. The Team will depart for Antwerp on or around Tuesday 10 April 2018 (tbc).</li> </ol>
<b>Announcement</b>	<ol style="list-style-type: none"> <li>1. The Team will be announced on or before <b>Friday 23rd February 2018</b>. Selected Team Members agree not to make any announcement to the media or public in any form (including through social media) regarding their selection until after British Gymnastics have announced the Team selection on the British Gymnastics website (<a href="http://www.british-gymnastics.org">www.british-gymnastics.org</a>).</li> </ol>
<b>Any additional matters not covered by this Policy</b>	<ol style="list-style-type: none"> <li>1. Any matters arising from the selection process that are not covered within this policy shall be determined by the Approval Panel (or representative thereof) acting at their sole discretion.</li> </ol>
