Re: UEG Coaches Course – July 2017

British Gymnastics is delighted to receive an invitation to attend the UEG Coaches Course, based in Cesenatico (ITA), 2nd – 8th July 2017.

The official communication is attached within detailing the venue, accommodation costs and transport costs upon arrival in Italy. A maximum of 5 coaches per Federation may attend the course. With British Gymnastics, the Technical Committee are inviting applications from coaches working at a Senior Club level or equivalent*, who are a current member of British Gymnastics and who hold a valid DBS and a valid Safeguarding & Protecting Children award.

** Applications from lower level coaches may be considered in exceptional circumstances. These applications must be accompanied by supporting documentation providing a rationale as to why the application should be considered.*

All costs will be funded by the individual applicants, including flights and the logistics of travel. The cost payable to the UEG will be 500 Euros per person to include full board accommodation. Please note there are additional costs for airport transfers.

We are inviting coaches / clubs who wish to be considered, to apply using the attached form to be submitted by **Friday 21st April 2017**. Applicants will be considered by the Technical Committee Chair and the Performance Manager by 28th April 2017, based on fulfilling the eligibility / qualification criteria and on a first come first served basis.

In signing and returning the request form, you are accepting 100% of the costs of attending the camp. British Gymnastics will pay the organising committee in advance of the event and successful candidates will be required to fully reimburse British Gymnastics, including bank charges, no later than Friday 2nd June 2017. If payment is not submitted by this date, the Selection Panel has the right to move to the next coach on the list.
