



Information Regarding Competing Abroad for Double-Mini Trampoline & Tumbling in 2018

As well as fulfilling important welfare and insurance requirements, the eligibility to compete abroad will promote, protect and quality assure the GBR Double Mini-Trampoline & Tumbling 'Performance Brand', maintain its profile internationally and most importantly support athlete development by ensuring they compete at the competitions appropriate to their stage of development.

All Home Nations and Clubs wishing to enter any FIG sanctioned events and non-FIG sanctioned competitions for DMT & TUM must follow the British Gymnastics (BG) eligibility and application process as detailed below.

1. FIG sanctioned events (Home or Abroad) in 2018

All FIG sanctioned events (or events organised alongside FIG sanctioned events) will be prioritised for GBR National Team use. The reason for this is to retain 'exclusivity of use' for these events and to avoid any possible clash or conflict with selected National Teams.

Please note - if a GBR National Team is not attending a FIG sanctioned event this will be published on the BG website as soon as possible so that Home Nations or Clubs with gymnasts fitting the criteria set out below may apply to attend.

- Eligibility to enter FIG sanctioned events is open to FIG level gymnasts who have competed at the British Championships 2016-2017 or have qualified for the 2018 British Championships as per the Competition Handbook.
- Previous GBR international gymnasts may submit an application for approval along with proof of current performance level.

2. Non-FIG sanctioned international events 2018

If neither the GBR National Team or any Home Nation is attending a non-FIG sanctioned event Clubs may apply to enter a maximum of 2 events each calendar year. (Home Nations & Clubs may not attend the same competition event).

- Eligibility to enter non-FIG sanctioned events is open to Clubs who have competed at the Regional Team Final, NDP Final, Spring Event Series or British Championships 2015-2018.

Please note that any gymnast who is returning from injury or an ex National Squad member who doesn't fulfil these requirements may submit an application with supporting evidence of ability to compete at the level requested.'

Application Process

Providing gymnasts can fulfil the above eligibility criteria the following process must be followed;

1. Clubs need to complete and submit the attached application form for approval, to the Non-Olympic Programme Officer; nadine.barnard@british-gymnastics.org. The application will be processed and considered by the Performance Team in consultation with the National Technical Committee Technical Panel and a decision made within two weeks of receipt.

2. Once the applications have been agreed the travel application forms will need to be completed and submitted to the BG membership department through the usual process.
3. Clubs will also need to submit the names of their judges along with the relevant qualification to the National Judging Officer.

NB Home Nations may choose to process these entries through their own internal systems but the National Technical Committee Chair and the National Judging Officer must still be copied in as required above.

Reminders:

Home Nations & Clubs must seek permission from BG for all entries into international events that offer invitational entry. This is also a requirement from FIG to protect event organisers.

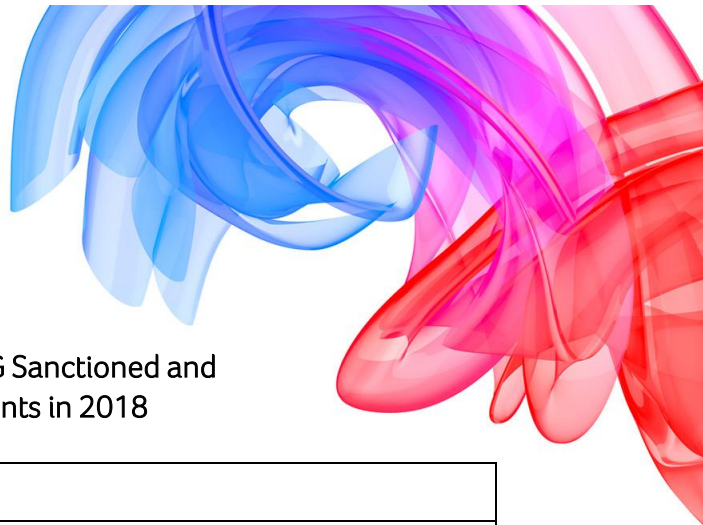
Clubs should also remember that only official GBR Teams are permitted to wear GB insignia on tracksuits and leotards.

Clubs or individuals ignoring these requirements above will risk being denied entry into future domestic competitions in the UK.
